- 4. The Buyer agrees to pay for all purchases within the agreed upon Net terms (determined upon completion of credit evaluation).
- 5. The Amount Due (the total outstanding on the invoice) must be paid in full no later than the number of days of your determined Net terms, after the Goods are shipped, delivered, and/or installed by the Seller, in this case Simco Sign Studios, Inc. - 6. Simco Sign Studios, Inc. reserves the right to remove terms from any account that doesn't pay the full amount due within the established Net terms. Simco Sign Studios, Inc. also reserves the right to place an account on hold for past due balances.
- 7. A 1½% surcharge will be applied to any balance that is past due. Any delinquent accounts past 90 days will be handed over to a collection agency, as well as reported to all major credit bureaus.
- 8. The Buyer agrees to pay \$25 for each check issued by the Buyer to Simco Sign Studios, Inc. which is returned to Simco Sign Studios, Inc. unpaid or marked NSF.
